## CALL FOR APPLICATIONS 002/2025/MPFMC - amended on October 10, 2025

The Coordination of the Professional Master's Program in Pharmacology (MPFMC), School of Biological Sciences, Universidade Federal de Santa Catarina, announces the opening of the application process and selection exam for the Master's degree program, between **September 05<sup>th</sup> and November 27<sup>th</sup>, 2025**, with admissions available for the 2026 class.

### 1. APPLICATIONS

**1.1** To apply, the documents listed below must be compiled **into a single PDF file**. Ensure the file is named with the applicant's full name and that the documents are arranged in the following order:

1. Proof of online application (available at <https://capg.sistemas.ufsc.br/inscricao/home.xhtml>);
  2. Letter of Motivation: The applicants should prepare a letter (maximum of 4 pages, A4 size, using a 12-point font and 1.5 line spacing) that includes the following information:
    - a) the reasons for interest in the Professional Master's Program in Pharmacology;
    - b) the contribution of the Professional Master's Program in Pharmacology to their professional career and to the place where they currently carry their professional activities;
    - c) a minimum of one research project proposal to be developed during the Professional Master's Program in Pharmacology;
    - d) the area of concentration to which they are applying, as listed in Table II of this Call for Applications;
    - e) their availability of time and location to carry out the research project;
    - f) professional and/or academic activities included in their *Curriculum vitae* that they consider relevant.
  3. A copy of the Degree Certificate (Diploma) or Degree Completion Certificate or Certificate of Enrollment in the last semester of the Undergraduate program;
  4. A copy of the Identification Card and Individual Taxpayer Number (or a valid passport, for foreigner applicants);
  5. A copy of the applicant's updated *Currículo Lattes* (original or certified copies of supporting documents must be presented to the Selection Committee upon request).
  6. Applicants must indicate whether they want to apply for a place reserved under the Affirmative Action and Equity Program. Those applying for these reserved places must include the SELF-DECLARATION FORM (**Annexes III, IV, V, VI e VII**) with their application. Only one out of the five categories must be indicated (black and *pardos* or indigenous or *quilombolas* or people with disabilities or other categories of social vulnerability). The file should be named: applicant\_name\_self\_declaration.pdf.

## **2. THE SELECTION COMMITTEE, THE EXAMS SCHEDULE, AND THE STAGES OF THE SELECTION**

The Selection Committee will be announced after the application period has closed.

This Selection Process consists of two stages:

- **STAGE 1 – WRITTEN EXAM** (December 5<sup>th</sup>, 2025), to be held in person in Room 12 (ground floor) of Block D (Pharmacology) of the Center for Biological Sciences (CCB);
- **STAGE 2 – EVALUATION OF CURRICULUM VITAE AND LETTER OF MOTIVATION, KNOWLEDGE IN PHARMACOLOGY FOLLOWED BY AN INTERVIEW WITH THE APPLICANT** (December 9<sup>th</sup> and 12<sup>th</sup>, 2025) via videoconference.

### **STAGE 1 – WRITTEN EXAM – December 5, 2025 – 8:30 AM – room 12 (ground floor) of Block D (Pharmacology) of the Center for Biological Sciences (CCB)**

The written exam will consist of objective and/or essay questions on pharmacokinetics and pharmacodynamics. It will begin at 8:30 AM. on December 5, 2025, in Room 12 of Block D of the Biological Sciences Center and will last a maximum of two hours. It is essential that the candidate has their registration number on hand, as this number will be used for identification purposes.

Essay questions are evaluated by a committee of three faculty members based on the following criteria: conceptual accuracy, soundness of arguments, clarity of presentation, and quality of writing. The final grade for each essay question is calculated as the arithmetic average of the scores given by the evaluators. The answer key for any objective questions (if applicable) will be posted after the announcement of the written exam results.

The **evaluation of the content of the applicant's Curriculum Vitae and Letter of Motivation** will be scheduled between 8 AM and 5 PM on December 9<sup>th</sup> and 12<sup>th</sup>, 2025, depending on the availability of the Selection Committee. This stage will be conducted via videoconference.

**Notes:**

1. The minimum passing grade in the STAGE 2 is six (6.0).
2. The scheduling of this stage will be done according to the alphabetical order of the applicant's names in the Selection Process. Applicants must contact the Selection Committee in advance to submit copies of each original supporting document for the activities mentioned in their *Currículo Lattes*.
3. In STAGE 2, applicants will be evaluated and interviewed on:
  - a) The information in the Curriculum Vitae, which must be verified with original documents or certified copies. The evaluation will be based on the following criteria:
    - a. Academic activities: Degree Certificate (diploma) or Degree Completion Certificate or Certificate of Enrollment in the last semester of the Undergraduate Program (3.0 points). Specialist Certificate, Master's Degree or PhD diploma (up to 0.75 points). Publication of a scientific article and/or chapter of a book (up to 0.375 points). Presentation of a poster and/or publication of an abstract at a scientific/professional conference (up to 0.25 points). Participation in teaching activities, scientific internships, research and/or outreach projects (up to 0.25 points). Participation in scientific/professional conferences (up to 0.25 points). Other activities (up to 0.125 points);
    - b. Professional activities: Work in the field of expertise (0.125 points/year, up to a maximum of 2.5 points). Work as teacher/supervisor (0.125 points/year, up to a maximum of 1.25 points). Work as supervisor of scientific/professional internships (0.05 points/semester/student, up to a maximum of 0.5 point). Organizer of scientific/professional events, instructor of scientific/professional courses or lectures (up to 0.05 points/event, maximum of 0.25 points). Approval in civil service examinations (0.05 points/event, maximum of 0.25 points). Other activities (up to 0.25 points).
  - b) Your interest in the Professional Master's Program in Pharmacology and how it will contribute to your professional development;
  - c) Your initial proposal for the development of the thesis, including its feasibility and alignment with the research topic of one of the faculty members with an available place in this Call for Applications, items that must be formally described in the letter of motivation.
  - d) Knowledge of Pharmacology
3. The applicant must carry the original documents submitted during the application process, as well as the supporting documents for the activities described in the Currículo Lattes, such as diplomas, certificates, copies of publications, declarations regarding the duration of professional experience, teaching activities, internships (and/or supervision of internships), tutoring, etc.
4. The final grade in this stage will be equal to the arithmetic average of: i) the evaluation of academic and professional activities; ii) the clarity of the letter of motivation submitted by the applicant; iii) the applicant's understanding of the feasibility, relevance, alignment with the available places and research tracks in this Call for Applications, and potential limitations of the initial proposal for the developments of the master's thesis.
5. The tiebreaker criterion will be the grade obtained in STAGE 2.

### 3. APPROVALS

To be approved in this selection process, the applicant must achieve a minimum passing grade of six (6.0) in each of the two stages.

### 4. RANKING AND EXAM LOCATIONS

The final ranking will be determined according to the weighting/grades table below:

### 5. NUMBER OF PLACES PER FACULTY MEMBER AND RESEARCH TRACKS

This Call for Applications aims to fill up to **thirteen (13)** places in the Professional Master's Program in Pharmacology for the period from March 2025 to February 2027. Although the program has a larger number of accredited advisors interested in supervising students, the total number of available positions is limited to 13 (thirteen). Accordingly, the allocation of positions per advisor will be carried out in compliance with this limit, within the respective areas of concentration presented in Table II.

- One place is reserved for a person with a disability, in accordance with the implementation of Section VIII of Article 37 of the Federal Constitution and, by analogy, of §2 of Article 5 of Law no. 8.112/1990, combined with Decree no. 3.298/1999, Articles 3 and 4 (as amended by Decree no. 5.296/04) and Article 2 of Law no. 13.146/15.

- One place is reserved for applicants who are beneficiaries of the University for All Program (PROUNI) of the Federal Government, or recipients of scholarships aimed at undergraduate students from public higher education institutions in situation of socioeconomic vulnerability.

**6.1.** Applicants must indicate in the application form, in the specific box, whether they want to apply for a place reserved for Affirmative Action and Equity, only one of the categories must be indicated. The required documents for each category, to be submitted upon application, is detailed below:

**6.2.** Places reserved for black people (black and *pardo*):

a) Form in which they declare themselves as black or *pardo*, according to the color/race category used by the Brazilian Institute of Geography and Statistics (IBGE), for applicants applying for places reserved for black (black and *pardo*), as per Annex III of this Call for Applications.

6.2.1 The validation of the self-declaration as black or *pardo* will be carried out by the Self-declaration Validation Committee, and specific elaborated to this end, named by the Prorectorate for Affirmative Action and Equity (PROAFE), according to the following criteria: applicants self-declared as black or *pardo* must present phenotypic traits that characterized them as belonging to the ethnic group black. In accordance with the Supreme Court, the constitutionality of heteroidentification for applicants self-declared black was established in the rejection of the Action for Non-compliance with Fundamental Precept no. 186, with the criterion being phenotypic rather than ancestry.

6.2.2. The validation process may take place in person, through video analysis, or via videoconference with recorded sessions. The video may be used to appeal to any rejection of the self-declaration and the applicants must confirm that they were the ones who signed the self-declaration as black (black or *pardo*). During the validation process, applicants must arrive early and should not be wearing any cap/hood/beanie or any item that conceals their face, and preferably have their hair down. It will not be permitted for another person to accompany the applicant during the validation process.

6.2.3 Applicants who have been approved by Black Validation Committees for undergraduate and graduate programs at UFSC based on phenotypic criteria are exempt from undergoing a new validation process, as long as they provide proof of prior validation for administrative validation.

**6.3.** Places reserved for indigenous people:

a) form in which they declare themselves as indigenous, indicating which ethnic group they belong to, the name and city of the village, and the state of the federation, as per Annex V of this Call for Applications.

b) Declaration from the indigenous leadership or other representative indigenous organizations; or a declaration of belonging to an indigenous group signed by a recognized indigenous leader.

I. This declaration must be original, and a method of verifying its authenticity is necessary, such as a copy of the leader's identification card (front and back), phone number, notarization, digital certificate, or other means.

c) Applicants who have been approved by Indigenous People Validation Committees for undergraduate and graduate programs at UFSC are exempt from undergoing a new validation process, as long as they provide proof of prior validation for administrative validation.

6.3.1. Self-declarations will be confirmed by the Self-declaration Validation Committee, named by the Prorectorate for Affirmative Action and Equity (PROAFE), and specifically elaborated to this end.

6.4. Places reserved for people with disabilities:

6.4.1 In accordance with Law no. 13.146/15 (Statute of Person with Disabilities), for the purposes of this Call for Applications, a person with a disability is considered to be someone who has a long-term physical, intellectual, and/or sensory impairment that, when interacting with one or more barriers, may hinder their full and effective participation in society on an equal basis with others.

6.4.2. Individuals who present only aesthetic deformities and/or sensory impairments that do not constitute a disability and/or restriction to their past learning performance are not eligible to apply for the places reserved for people with disabilities.

6.4.3. Individuals with specific functional disorders (dyslexia, dyscalculia, dysgraphia, attention deficit hyperactivity disorder) are not eligible to apply for the places reserved for people with disabilities.

6.4.4. Applicants may be eventually called for a videoconference interview by the Self-declaration as People with Disabilities Validation Committee.

a) Self-declaration form for people with disabilities, Annex VI of this Call for Applications.

b) Medical report, drawn up no more than twelve months prior to applying for this selection process, which must be signed by a doctor specialized in the applicant's disability, containing, in clinical description, the degree or level of disability, with express reference to the corresponding code of the International Classification of Diseases – ICD and a description of the impact of the disability on functionality. It must also contain the legible name, stamp, signature, and CRM number of the doctor who provided the certificate.

c) In addition to the medical report, applicants with Hearing Impairment (Deafness), must provide the following examinations: audiometry (tonal and vocal) and immittance audiometry, carried out no more than twelve months prior to applying for this selection process, containing the legible name, stamp, signature and CRM number of the professional who carried out the examination.

d) In addition to the medical report, applicants with Visual Impairment must provide an ophthalmological examination showing visual acuity, carried out no more than twelve months prior to applying for this selection process, as well as the legible name, stamp, signature and CRM number of the professional who carried out the examination.

e) For applicants with autism, the medical report should include, in addition to the specifications described in item a, information on communication, behavior, and interpersonal relationships, as well as confirmation that the symptoms occurred before the age of 18.

6.5. Places reserved for other categories of social vulnerability.

a) Form in which they declare themselves as *quilombola*, indicating the name of their *quilombola* community, the city of the community and state of federation, as per Annex IV of this Call for Applications.

b) Declaration signed by a *quilombola* leadership, with its respective phone number. This declaration must be original, and a copy of the leader's identification card (front and back) should be presented for signature authenticity verification. Alternatively, the declaration may be notarized, in which case the presentation of the leader's identification document is not required.

c) Applicants who have been approved by Quilombola Validation Committees for undergraduate and graduate programs at UFSC are exempt from undergoing a new validation process, as long as they provide proof of prior validation for administrative validation.

6.5.2 Self-declaration will be confirmed by the Self-declaration as Quilombola Validation Committee, named by the Prorectorate for Affirmative Action and Equity (PROAFE), and specifically elaborated to this end.

6.6. Unfilled Affirmative Action and Equity places in the selection process will be allocated to the Open Competition.

6.7. Applicants opting for Affirmative Action and Equity also compete for Open Competition places.

6.8. Applicants opting for Affirmative Action and Equity who achieve a sufficient grade will fill Open Competition places.

6.9. Applicants whose self-declaration is not approved will only compete for places in the Open Competition category.

6.10. If multiple applicants are competing for the same place with a given supervisor in a specific research track, the applicant with the highest final grade will be selected, while also ensuring that Affirmative Action and Equity places are upheld. In the event of a tie in the final grade, the applicant with the highest grade in STAGE 2 will be selected. Should the selected applicants withdraw, the next highest-ranked applicant in the same research track may be called. If no applicants are classified for a particular research track, the supervisor responsible for that track may choose to offer the place to another applicant who was classified in a different track but did not secure a place. The Professional Master's Program in Pharmacology reserves the right to admit fewer applicants than the number of places indicated in this Call for Applications.

## **7. PUBLICATION OF FINAL RESULTS AND DURATION OF THIS CALL FOR APPLICATIONS**

A list containing the approved and ranked applicants in the selection process will be published on the MPFMC website (<http://mpfmc.paginas.ufsc.br>) starting from December 16th, 2025. This Call for Applications will be valid for 120 days.

## **8. APPEALS**

Appeals regarding any of the stages of the selection process (applications approval, STAGE 1 and STAGE 2) must be formally submitted (**Annex II**) to the Coordination of the Professional Master's Program in
